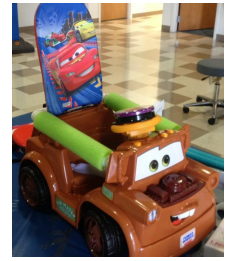

- I agree that all toys borrowed by myself for trial purposes shall receive reasonable care while in my possession and shall be returned at the end of the borrowing period in a clean, dry, and working condition.
- I hereby agree that borrowed toys remain, at all times, the property of Katelyn's Krusiers and that I am liable for the payment of costs, up to the replacement value of the toy, for toys that are damaged, lost, stolen, or unreturned while borrowed by me.
